REVIEW OF OVERSEAS TRADE

During the month of March 2015, total imports to Barbados were valued at \$264 million, whilst total exports from Barbados were valued at \$78 million. This resulted in a visible trade deficit of \$182.2 million, as compared with a visible trade deficit of \$203.5 for March 2014.

Imports for March 2015 were \$26.2 million less than imports for March 2014, a decrease of 9.0%. Total exports decreased by \$8.9 million or 10.2% of the March 2014 figure. Domestic exports decreased by \$2.3 million or 4.9% over March 2014, while the value of re-exports decreased by \$6.6 million or 16.4% over the corresponding period 2014.

For the period January – March 2015, the value of imports to Barbados was \$746 million, whilst the value of total exports was \$226 million representing an accumulated visible trade deficit of \$519.8 million as compared to a similar deficit of \$600.6 million for January – March 2014.

Imports for January – March 2015 were \$99.1 million less than imports for the same period 2014, a decrease of 11.7%. Total exports showed a decrease of some \$18.3 million or 7.5% over the January - March 2014 figure. Domestic exports decreased by \$4.2 million or 3.3% over January – March 2014. The value of re-exports decreased by \$14.1 million or 11.8% over the corresponding period 2014.

CARICOM TRADE

During the month of March 2015, total imports from CARICOM countries were valued at \$50 million, whilst total exports to CARICOM were valued at \$24 million, resulting in a trade deficit of \$25.8 million as compared with a visible trade deficit of \$55.6 million for March 2014.

Total CARICOM imports for March 2015 were \$35.6 million less than CARICOM imports for March 2014, a decrease of 41.6%. Total exports to CARICOM for March 2015 were \$5.8 million less than total exports for March 2014, a decrease of 19.4%. Domestic exports decreased by \$5.4 million or 20.9% over March 2014. The value of re-exports decreased by some \$0.4 million, or 10.0%, over the March 2014 figure.


For the period January – March 2015, total imports from CARICOM were valued at \$154 million, whilst total exports were \$74 million resulting in an accumulated visible trade deficit of \$80 million as compared with a deficit of \$210 million for the same period of 2014.


During this period, CARICOM imports were approximately \$136.0 million less than those over the same period in 2014, a decrease of 46.9%. Total exports to CARICOM for January – March 2015 were \$6.3 million less than total exports for the corresponding period 2014, a decrease of 7.9%. Domestic exports decreased by approximately \$7.2 million or 10.6% over the same period 2014. The value of re-exports increased by \$0.9million or 7.8% over the January – March 2014 figure.
